2. Signs and Markers

Several mine identification signs at varied locations of access into the mining permit area were evaluated during the course of the partial inspection. The signs are all uniform and contained all of the required information as required by law.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The facilities and dryer ponds were observed and contained minimal snow in the reaches of the pond . The ponds are incised and no structural concerns or hazards were observed.

4.c Hydrologic Balance: Other Sediment Control Measures

Several (not all) sediment control structures were visited as part of the partial inspection. The majority of these structures that were visited are using straw wattles as the control measure. A few of the culverts on the South Eastern side have had oil skimmers installed into the inlets of the culverts in case there is an oil spill associated with the oil trans-loading activities that are occurring outside of the disturbed area associated with the mining permit area.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile is a low profiled pile. The pile appeared stable. No visible hazards were observed during the inspection.
