## **2. Signs and Markers**

All public access points into the mining permit area are clearly marked with identification signs as required by regulation. The signs contain all of the required information.

### **4.a Hydrologic Balance: Diversions**

Several diversions were spot checked during the partial inspection and were found to be in compliance with the approved designs within the approved mining and reclamation plan.

### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

Several sediment ponds have minimal water in them from the most recent rain storm that occurred yesterday afternoon. The ponds that were observed are stable. No visible hazards were observed.

## **8. Noncoal Waste**

The site was free of noncoal waste items outside of containments.
