2. Signs and Markers

All points of access into the mining permit area have a identification sign posted at the entrance. The signs are consistent and contain the name, address, phone number and mining permit number in compliance with the regulations.

3. Topsoil

Topsoil piles have straw wattles installed as a protection measure.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Most of the sediment ponds were moist in the base of the ponds, but no standing water. Embankments appeared stable.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared stable. No visible hazards.

Mining of the slurry cells is still taking place. Pictures of the mining areas were taken and are attached to the PDF version of this inspection report.

8. Noncoal Waste

The site was free of noncoal waste items during the partial inspection.
