2. Signs and Markers

Each entrance into the mining permit area is clearly posted with an identification sign listing the name of the operator, address, phone number and permit number. The signs are all uniform and consistent with each other.

4.a Hydrologic Balance: Diversions

Several diversions were inspected as part of the partial inspection. These diversions were open and functional according to design.

7. Coal Mine Waste, Refuse Piles, Impoundments

Slurry cells are being mined out and material sent to a co-generation plant. Material from the excavation of the slurry cells is being pushed into piles and then loaded into double trailers. Mining and hauling was not occurring during the inspection. No visible hazards were observed during the inspection.
