2. Signs and Markers

The identification signs are posted at every entrance into the mining permit area. The signs are in compliance with the requirements.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

All sediment ponds were found to be dry.

4.e Hydrologic Balance: Effluent Limitations

All of the UPDES discharge points were checked as part of the partial inspection. No discharges were occurring from any of the approved outfalls.

5. Explosives

No explosives are stored on site.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared stable. No visual hazards were observed on the refuse pile.
