2. Signs and Markers

Viewed several of the identification signs at various entrances into the permit area from a public access point. The signs are current with the required information clearly displayed on them. The signs are in compliance with the regulations.

4.a Hydrologic Balance: Diversions

Viewed several diversions on the Southwest side of the permit area. The diversions that were observed were functional, with some grass in its reaches.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The dryer pond was observed and discussed as part of the partial inspection. Viewed maps with drainage paths identified that have been prepared in preparation for the proposed post mining changes.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile is still inactive. The pile appears stable. No visible hazards were observed during the inspection.

22. Other

Active mining of the slurry cells has begin once again. Mining was not occurring during the inspection. Piles of slurry fines has been pushed into stockpiles to allow the material to be loaded into double trailers and hauled to the Sunnyside Cogeneration Plant in Sunnyside, Utah. The slurry fines are being used by Sunnyside Cogeneration as a fuel supply for their power generating plant. It is evident that the surface of the current slurry cell has been lowered do to the mining activities.
