2. Signs and Markers

All points of access from a public road are clearly marked with an identification sign that gives the name of the company, phone number, address and the permit number. This is required by law and is in compliance with the law.

4.a Hydrologic Balance: Diversions

Diversions are open and functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The clear water pond has had all of the woody species (Tamarisk) removed from the interior embankments. The woody species are placed into 16 different piles. The piles will be burned in place when it is determined that the impacts to air quality will be minimized.

The refuse pile appeared stable. No visible hazards.

16.a Roads: Construction, Maintenance, Surfacing

The roadways leading to and around the slurry cells have and were being watered for dust suppression as the haul trucks enter and leave the mining area.
