2. Signs and Markers

Identification signs are located at all access points into the permit area. The signs contained the name, address, phone number and mining permit number. The signs are in compliance with the Utah Coal Rules.

5. Explosives

No explosives or explosive storage facilities are maintained on site.

8. Noncoal Waste

The site was free of noncoal waste items outside of an approved storage or containment facility.

22. Other

Bob Long was on site taking soil samples from areas in the north slurry pond where slurry material has been removed. Three pits were excavated to allow the samples to be collected and information gathered. The pit designation were Pit #3, 4 and 5.

The tamarisk piles in the clear water pond have now been burned . There were approximately 6 piles of tamarisk that had been previously removed from the interior of the clear water pond.
