## **2. Signs and Markers**

The identification signs at all points of access into the permitted area are consistent. They clearly display the name, address, phone number and permit number of the operator.

### **4.a Hydrologic Balance: Diversions**

Diversions throughout the site are open and functional. Some work on the diversions near the dryer pond was completed in the last several months.

### **4.c Hydrologic Balance: Other Sediment Control Measures**

Straw wattle structures that were installed several years ago are still performing and functioning well.

## **5. Explosives**

No explosives are stored or maintained on site.

## **7. Coal Mine Waste, Refuse Piles, Impoundments**

Some of the small erosional cuts on the interior of the clear water pond have been hand raked and covered over. The tamarisk was also removed from the interior several months ago.

## **8. Noncoal Waste**

The site was free of noncoal waste items outside of an approved containment structure or facility.

## **22. Other**

No mining or material haulage was occurring during the partial inspection.
