2. Signs and Markers

All points of access that go into the mining permit area are clearly posted with an approved identification sign that indicates the name, address, phone number and permit number. These posted items meet the requirements set forth by regulation.

4.a Hydrologic Balance: Diversions

The diversions observed appeared to be functional, especially with the rain storm that occurred yesterday. The site is still muddy from the storm.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment ponds have a small amount of standing water in the base of the ponds from the most recent rain storm yesterday. Ponds appeared stable. No visible hazards were observed during the inspection.

5. Explosives

No explosives are stored on site.

7. Coal Mine Waste, Refuse Piles, Impoundments

Both refuse piles are clearly posted. They appeared to be stable, No visible hazards were observed.

8. Noncoal Waste

The site was free of noncoal waste items outside of approved containment facilities.

16.a Roads: Construction, Maintenance, Surfacing

Roadways throughout the site were wet and muddy from the rain storm that occurred yesterday. The roads are well maintained and graded.
