2. Signs and Markers

All entrances leading into the permit area are well placard with identification signs that clearly display the name, address, phone number and Utah Mining Permit number of the operator.

3. Topsoil

Protection of the topsoil pile includes vegetation along with alternate sediment control consisting of straw wattles and straw bales.

4.a Hydrologic Balance: Diversions

Diversions have melted off and are damp and muddy. Diversions appear functional according to design.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Ponds are dry with the bottoms being damp from recent snow melt. Embankments appear stable. No visible hazards were observed during the partial inspection.

4.c Hydrologic Balance: Other Sediment Control Measures

5. Explosives

No explosives are stored on site.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse piles appeared stable. No hazards were apparent during the visual observation of the piles.
