2. Signs and Markers

All entrances leading into the permit area from a point of public access are identified with an ID sign that clearly displays the name, address, phone number and mining permit area of the operator. The signs were inspected and found to be in compliance with these requirements.

3. Topsoil

Topsoil is placed into a topsoil pile and identified by a sign to prevent disturbance. Protection of the topsoil material is provided by vegetative growth, earthen beams, straw bales and/or straw wattles.

Diversions were open and functional

Sediment ponds were dry during the inspection.

SWPPP has been reviewed and updated by an authorized agent.

5. Explosives

There are no explosives on site.

7. Coal Mine Waste, Refuse Piles, Impoundments

Material from pond cleaning still needs to be spread out and compacted on the refuse pile. Pile's are stable. No visible hazards.
