In connection with the execution of a permanent program bond for the Geneva Mine Permit, we respectfully request the release of Kaiser Steel Corporation's \$250,000 bond obligation under the interim program. As you recall, Kaiser Steel Corporation deposited \$250,000 in Treasury Bills with the Division which have since matured and been deposited in an interest-bearing account with the State of Utah. Kaiser Steel Corporation would appreciate the return of this cash bond at the State's earliest convenience.
