Bonds Accepted Subleases Approved

On November 6, 1998, subleases of Federal coal leases SL-066145, SL-066490, SL-069291, U-014217, U-014218, and U-0126947, entered into on October 19, 1998, between UtahAmerican Energy, Inc. (UAEI), as sublessee, and Intermountain Power Agency (IPA), as sublessor, were filed in this office.

Satisfactory evidence of the qualifications and holdings of UAEI is on file in this office. We have received no information that the leases are not in good standing. The subleases appear to meet the requirements of the regulations and are hereby accepted effective March 1, 1999. Approval of the subleases does not constitute approval of any of the terms therein which may be in violation of the lease terms.

Surety bonds, with UAEI as principal, were filed in this office on December 22, 1998. The bonds have been examined, found to be satisfactory, and are hereby accepted as of the date of filing. The surety bond numbers and their amounts are listed below.
