The following notice of intent to construct, submitted in accordance with Section R307-401-1, Utah Air Conservation Rules, has been received for consideration by the Executive Secretary, Utah Air Quality Board:

Utah American Coal Company
 Location: 1382 Scenic View, Price, Utah 84501
 Project Description: Utah American Energy, Inc. has proposed to construct and operate an underground coal mine in Emery County. The new Lila Canyon Mine will be located approximately seven (7) miles Southwest of Columbia, Utah.

Emery County is an attainment area of the national air quality standards for all pollutants. Particulate emissions from handling coal will be mitigated by wet suppression. New Source Performance Standards (NSPS) 40 CFR subpart Y applies to this source. Therefore, Title V applies to this source. National Emission Standards for Hazardous Air Pollutants (NESHAP) regulations do not apply to this source. A 30-day public comments period will be required before granting an approval order.

The Proposed Emissions increase will be (A negative sign indicates a decrease in emission rates.):

The engineering evaluation and air quality impact analysis have been completed and no violations of National Ambient Air Quality Standards or Prevention of Significant Deterioration Increments will occur. It is the intent of the Executive Secretary to approve the construction project.

The construction proposal and estimates of the effect on local air quality are available for public inspection and comment at the Division of Air Quality, Utah State Department of Environmental Quality, 150 North 1950 West, Salt Lake City, Utah 84114-4820. There will be a 30-day comment period held. Written comments received by the Division, at the same address on or before July 8, 1999, will be considered in making the final decision on the approval/disapproval of the proposed construction.

If anyone so requests to the Executive Secretary at the Division in writing, within 15-days of publication of the Notice, a hearing will be held to explain the project and technical rationale for proposed action. A hearing will be scheduled as close as practicable to the proposed project location. Comments obtained during a hearing will be evaluated and considered to by Executive Secretary before making a final decision on the approval/disapproval of the project.
