The Southern Utah Wilderness Alliance (SUWA) is in receipt of the March 26, 2004 letter that you sent to UtahAmerican Energy Inc. regarding the Division's determination of administrative completeness for the Lila Canyon extension application. I am of the understanding that comments on the administrative completeness determination, along with any request for informal conference, are due by May 27, 2004.

As you know, SUWA is deeply interested in the Division's actions regarding this permit application, and we intend to submit questions and comments and possibly request an informal conference by May 27, 2004. In the interim, SUWA and SUWA's representatives plan to review the application and the Division's files pertaining to this matter. Any assistance that you and others could provide during this process would be greatly appreciated.

We are also aware that you are beginning your technical review of the application, and we are confident that you will request additional information from UtahAmerican Energy during your review process. Of course, we would like the opportunity to bring our general concerns and additional information to the attention of the Division so that it could fully address these concerns in the technical review process.
