**22. Other**

The reclamation project for the sediment pond #1 and drainage channel is not complete. The contractor rip rapped most of the channel, but left a fairly large section where the side channel meets the main artery. The area around the channel and the road leading to the channel has been gouged, but not seeded. Jay Marshall is waiting for the later in the fall to seed. The topsoil cover over the rock dust bin is approximately 3'. There is some rock dust along the margin of the reclamation project. This rock dust has fair amount of cryptogamic colonization. The rock dust bin has been gouged, but not seeded. Jay will seed later in the fall. The portal slope was gouged, but not seeded.
