Thanks for taking minutes of the meeting. I have attached my comments in track changes.

We do not have copies of your Native American consultation efforts. It would be helpful to have copies sent to both the Price Field Office and the State Office BLM so that we have a record of the NA letters. Without reviewing the record it is not possible to fully conclude that your consultation would be sufficient to meet the NA requirements for an ARPA excavation permit to mitigate site 42EM2517. For example, was the research design sent to the Tribes? It is standard operating procedure to complete NA consultation prior to issuance of an ARPA permit.
