No large birds were observed in flight about the mines disturbed area this day.

16.a Roads: Construction, Maintenance, Surfacing

Emery County road 126 was easily accessed this day. All of the snow adjacent to this road has melted and has been absorbed into the ground. Soil moisture conditions appear to be ideal for grading the new access. Access past the old Mine buildinga (permit area "A") was possible for a distance of approximately 150 feet past the Geneva Mine powder and cap storage magazine. Snow on the road prevents further access.
