Fourth quarter 2007 data has been inserted into the EDI pipeline, but the uploading of that information remains to be completed.

Second Quarter 2008 water monitoring is currently being conducted.

There is no activity occurring at this site, due to the raptor exclusionary period. The Permittee is preparing a bid package to conduct earthwork activities at the site, post-July 15.

4.d Hydrologic Balance: Water Monitoring

Mr. Marshall checked the electronic recording rain guage at the site this day. According to the collected data, no rainfall has been received. The Permittee has conducted some site monitoring (May 14) has recently been conducted. Big Stink spring was the only sample which was collected (i.e., had a collectable flow quantity). All channels at the site were dry this day. Vegetation on the undisturbed slopes above the proposed site were a light shade of green, indicative of receipt of some moisture.

A golden eagle was observed flying over the proposed mine site disturbance this day.
