1. Permits, Change, Transfer, Renewal, Sale

The Permittee provided a revised / updated Plate 5-2, SURFACE AREA / Official Disturbed Boundary Map to the Division inspector which shows the temporary facilities which have been installed to date. The Permittee needs to submit this updated map for permit processing.

2. Signs and Markers

Permittee identification signs were posted at each point of access to the mine disturbance from the EC road # 126. All required information is listed.

3. Topsoil

There is no stripping of topsoil occurring at this point in time.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Both sediment ponds were observed as dry; no compliance issues were identified.

4.d Hydrologic Balance: Water Monitoring

The Permittee's water monitoring person notified the Division on March 14, 2011 that the 4th Quarter of 2010 water monitoring data for the Lila Canyon Mine had been uploaded into the DOGM electronic data base pipeline, and it was ready for uploading. As observed this day, there was no flow in either the left or right forks of Lila Creek. All disturbed ditches were dry.

9. Protection of Fish, Wildlife and Related Environmental Issues

No wildlife was observed during today's inspection.

13. Revegetation

The Permittee seeded four areas of inslope at Pond #1 (2 on the north inslope / 2 on the south inslope) on July 22, 2010. This is a requirement established within the MRP to test whether summer seeding will increase establishment of the warm season species. To date, the four areas are not showing any sign of germination. (See Horse Canyon MRP Part B, Section 341.300, page 26, and Section 354, page 28).

14. Subsidence Control

At this time, secondary extraction is not occurring within the underground works.

20. Air Quality Permit

The portal access road had recently been watered in order to control dust.

22. Other

Two small fuel spills were observed at the bulk tanks fueling facility located along the portal access road. The Permittee was instructed to clean up the contaminated soils.
