Dear Mr. Haddock:

On February 8, 2012 UEI submitted a Phase III application for Ditch #31 at Horse Canyon. It was returned to UEI on March 2, 2012 rejected. By means of this letter UEI is resubmitting the application.

As you are aware on November 30, 2009 UEI received Phase III bond release on all areas of Horse Canyon Part "A" except for a small ditch near the coal refuse pile (Ditch #31). The bond was not released on ditch #31 because of some repair work that was completed during the Phase III release time period.

It was determined by DOGM to observe Ditch #31 for two years to determine if the repairs were adequate for release. It has been over two years and the repairs appear adequate. No additional repair work has been done to Ditch #31 and it has remained stable.

By means of this letter and submittal, UEI is resubmitting the request for Phase III bond release on Ditch #31.

Once Phase III is obtained on Ditch #31, then all surface areas of Horse Canyon Part "A" will have Phase III release. Lila Canyon liabilities will continue under Part "B".

A public notice was advertised in the local papers for four weeks. The comment period will end on May 10th. A proof of publication is included with this application.

The previous C1 and C2 forms are still appropriate and have been resubmitted.

Ditch #31 (0.49 Acres)**

The purpose of this application is to request Phase III Bond Release for the 0.49 acres of Ditch #31. On November 30, 2009 Phase III Bond Release was approved for all of the Horse Canyon Mine Part "A" except for the 0.49 acre Refuse Pile Channel. Bond was held in the amount of \$8,000 for any future channel (Ditch 31) repairs. Water monitoring was to continue until the liability period for Ditch 31 was complete. That liability period was set at two years.

Application Format

This application is formatted following Technical Directive Tech - 006, Requirements for Phased Bond Release, March 23, 2001. The format is such so that the submittal can be added as a new Appendix III-1-7 to the existing approved Phase III Application.

This application will present the appropriate Technical Directive section headings is bolded followed by responses as follows:

5. Procedure
Prior to Bond Release Request

The reclamation plan and modifications to the reclamation plan including changes in the post mining land use and those changes that result during reclamations, have been approved by the Division and incorporated into the mining plan (MRP). All permit revisions have been approved by the Division and incorporated into the MRP.

No Post Mine Land Use Changes were required for this submittal.

1. Certify Reclamation

No additional reclamation was required for this submittal. The refuse pile drainage (ditch 31) was to be observed for an additional two years to confirm stability. The location of ditch 31 is shown on the attached Plate III-2A. (Attachment "A")

I. D. PERMIT CONDITIONS

There are no outstanding permit conditions.

II. A. 1. Legal description of the permit area.

The permit area is shown on the Lila Point, and Cedar U.S. Geological Survey 7.5-minute Quadrangle maps. The areas covered in this Phase III Bond release application include

Ditch 31 containing 0.49 Acres.

Ditch 31 is the only remaining area of Horse Canyon Part "A" where Phase III bond Release has not been obtained and is included in this Phase III Bond Release application. This area can be seen on Plate III-2A.

II.A.5. Mining history and reclamation activities

The Horse Canyon Mine was initially opened by the Defense Plant Corporation in 1942 as a source for coal for the Geneva Steel Works in Orem, Utah. The mine was sold to U.S. Steel in 1946, who operated it until January 1984, when mining was permanently suspended. U.S. Steel submitted a mining and reclamation permit application in March, 1981. In October 1982, U.S. Steel informed the Division that it was temporarily suspending mining operations, and in January 1984 permanent suspension was announced.

In November 1984, Kaiser Steel Corporation purchased the mine property and submitted a reclamation bond in the amount of \$918,649, and indicated to the Division that it would maintain the operations in a temporary suspension status until further corporate decisions were made. In February 1987, Kaiser Coal, successor to Kaiser Steel filed a petition for bankruptcy under Chapter 11, Title 11, of the U.S. Bankruptcy Code. Intermountain Power Agency (IPA) acquired the mine and the permit was transferred to IPA in August 1990. IPA was issued a mining and reclamation plan on May 6, 1991, and a reclamation bond in the amount of \$1,950,000 was issued in the form of a letter of credit.

Reclamation work proceeded on 51.56 acres of the 74.26 acres in 1990 and 1991. Phase I bond release was granted on February 5, 1997 for \$812,276. Phase II bond release application was submitted on December 19, 1997.

UtahAmerican Energy, Inc. acquired the mine from IPA on December 21, 1998. Phase II bond release was granted on April 11, 2002.

Phase III bond release was granted on November 30, 2009 for all areas but 0.49 acres involved with Ditch 31.

II.A.6. Extended Responsibility

There is no extended responsibility period for the Horse Canyon Mine.

II.A.7. Remaining sediment control structures

There are no remaining sediment control structures that need to be removed.

II.A.8. Schedule and cost estimate for remaining reclamation

There are no areas remaining for reclamation.


