4.a Hydrologic Balance: Diversions

During the previous inspection (which was a complete OSM versight inspection), an issues was identified with the lack of maintenance on the ditch to the east of the topsoil stockpile. The ditch was inspected and was found to be properly ans adequately maintained. There were no issues identified with ditches or diversions during this inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment elevation levels reported in the most recent certified inspection report for Pond 1 indicated that the pond needed to be cleaned. Mr. Marshall stated that the contractor who was scheduled to clean the pond (Scamp) would do so within the week, upon completion of construction at the Burma pond. This item will be followed up by a phone call from DOGM to Mr. Marshall before the next inspection date. Pond 2 was snow-packed. No stability issues were identified at either pond, and all inlets and outlets were in order for proper function.

8. Noncoal Waste

No non-coal waste issues were identified during the inspection.
