4.b Hydrologic Balance: Sediment Ponds and Impoundments

Inspection included a follow up verification of the cleanout of Pond #2. Pond was properly cleaned. Inlet required minor grading after equipment entry and exit. Discussed need for as-builts of cleaned out pond. Mr. Marshall will provide as-builts in a timely manner. Pond #1 was dry. Inlets & outlets were functioning properly.

7. Coal Mine Waste, Refuse Piles, Impoundments

Waste from sediment pond cleanout was mixed with coal pile. Operator no longer has access to Wildcat loadout and will therefore need to address future plans for coal mine waste disposal.

18. Support Facilities, Utility Installations

Complete review conducted of all surface and support facilities. Verified up-to-date status of Plates 5-2, 5-5, 7-2, and 7-5. Field verified accuracy of maps. Surface facilities maps include all facilities that are built and that will be built. Buildings that are schedule to be built during Phase II of construction are included on the maps and in the bonding calculations.
