#### **4.a Hydrologic Balance: Diversions**

Ditches and culverts had been cleaned and maintained and were functioning properly.

#### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

Verification was done on the first quarter cleaning of Pond 2. The as-built drawings were corrected and verified as requested by OGM and field truthed for accuracy. The pond had minimal water. Pond 1 was dry. The inlets and outlets of both ponds were functioning properly.

#### **7. Coal Mine Waste, Refuse Piles, Impoundments**

Coal fines that were deposited on undisturbed areas resulted in a violation (NOV #10122) during the last complete inspection. A follow-up was done during this inspection for the cleaning of the coal fines. The fines had been cleaned as well as could be done through concentrating the fines in specific area and were vacuumed as well as could be done. Plans are being developed to convert the undisturbed area to disturbed so future coal fine deposits will not result in a violation.
