**4.a Hydrologic Balance: Diversions**

Diversions and ditches were operating as designed. A reminder was given for routine maintenance and regular upkeep.

**4.b Hydrologic Balance: Sediment Ponds and Impoundments**

Ponds 1 and 2 were both dry. There were no hazards or compliance issues identified during impoundment inspections. All inlets and spillways appeared capable of functioning properly.

**4.c Hydrologic Balance: Other Sediment Control Measures**

Silt fences and water bars were operating as intended. A reminder was given for routine maintenance and regular upkeep.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

The coal fines area (NOV #10122) was inspected. The area has been adequately cleaned. Through a follow-up phone call, Mr. Marshall explained that regular cleaning and maintenance of the area has been scheduled. The area will be cleaned by vacuum truck methods. The coal fines that are exposed to wind will be temporarily controlled through water spray dust control measures. The long-term solution will be to disturb the area and adequately protect the topsoil.
