**4.a Hydrologic Balance: Diversions**

The operator was in the process of maintaining diversions, ditches, and culverts during the inspection. The maintained ditches are properly designed with certified drawings. Flows and designs are functioning and designed. Surface drainage maps are accurate and have been field-truth verified.

**4.c Hydrologic Balance: Other Sediment Control Measures**

The inspection included visits to 5 underground breakouts that have been designated as Alternate Control Sediment Areas (ASCA). The ASCA's included the two north and three south breakouts. The ASCA's were functioning properly and as designed. All sediment and runoff collected is being re-directed into the mine entry as expected. The ASCA's will be monitored and maintained by the operator as needed.
