4.a Hydrologic Balance: Diversions

The undisturbed diversion for watershed area UA-1 on the south end of the permit area is in need of maintenance. A new diversion has begun cutting from rainwater runoff and is directing water from undisturbed areas to disturbed areas and into the sediment pond. Minimal amounts of maintenance can correct the problem. Ditches and culverts were in need of general maintenance due to heavy runoff. The issues will need to be addressed before the next DOGM inspection or technical visit.

17. Other Transportation Facilities

Conveyor belt areas were inspected for identification of areas that are being covered with wind-blown coal fines. Coal fines are being controlled through regularly scheduled cleaning by vacuum. There are areas that were not sufficiently cleaned through vacuum methods, and will need to be cleaned using hand tools, shovels, and buckets. The operator will need to walk the length of the undisturbed drainage for watershed area UA-1 and remove any coal fines from the streambed. There were no fines in the lower reaches, and no fines have left the permit area. There are no off-site impacts. The situation can be fixed with more diligent maintenance and better follow-up on cleaning efforts. The issue will need to be addressed before the next DOGM inspection or technical visit.
