## **2. Signs and Markers**

Mine identification sign is in place at the entrance into the mining permit area. The sign contains the required information.

## **3. Topsoil**

The berm around the topsoil pile has been re-established with the addition of more topsoil to the pile.

### **4.a Hydrologic Balance: Diversions**

A cinderblock was found in diversion DD-1a. This cinderblock was removed during the inspection. Tumble weeds were found at the inlets to disturbed culverts DD-2 and DD-20. The tumble weeds were removed during the inspection. Disturbed culvert DD-26 still has sediment inside of the culvert. The inlet is clear, but sediment is inside of the culvert and needs to be flushed out. The culvert is still functional. A purchase order has been cut to have the work done by SCAMP. This item was noted on the previous inspection on December 16, 2014. If work is not accomplished by the inspection in February 2015 enforcement action will be taken. This should allow ample time to accomplish the needed maintenance.

### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

Both sediment ponds were dry. Bottoms of the ponds have a light snow covering.. Slopes appeared stable. No visible hazards were observed during the inspection.

## **8. Noncoal Waste**

Observed minor noncoal waste throughout the inspection. Items were gathered during the inspection and disposed of properly.

Foundation work for the new crusher building is completed as well as foundation work for the new surface conveyor system.
