4.a Hydrologic Balance: Diversions

All of the diversions that required maintenance from the prior inspection have been maintained. The diversions are functional according the required design contain within the approved MRP.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The smaller sediment pond is scheduled to be cleaned. A purchase order has been issued to accomplish the work. The contractor has not mobilized yet.
