2. Signs and Markers

The mine identification sign was checked upon entrance in to the mining permit area from the public access road. All of the information contained on the sign is up to date and meets the requirements set forth in the Utah R645 Coal Rules.

4.a Hydrologic Balance: Diversions

The majority of the diversions were inspected as part of the partial inspection. The culvert inlet located just below the portal area along side of the access road needs maintenance. Water is able to flow through the culvert, but the sediment is building up and needs to be removed.

4.b Hydrologic Balance: Sediment Ponds and Impoundments
