2. Signs and Markers

The mine identification sign is posted at the entrance into the mine permit area. The required information is clearly presented and legible. Sign is compliant.

4.a Hydrologic Balance: Diversions

The diversions were checked and found to be functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The cleaning of the smaller sediment pond has been completed and the equipment moved to the West Ridge mine to clean the sediment pond there.

5. Explosives

Powder and Cap Magazines are properly signed and grounded.

16.b Roads: Drainage Controls

A small portion of road drainage needs to be directed into the adjacent diversion at the upper most switch back before portal area. Karin made notes of the area and will contact maintenance personnel to address the concern.
