2. Signs and Markers

The mine identification sign is posted at the entrance into the Lila Canyon Mine entrance. The sign provides all of the required information to the public upon entrance into the mining permit area. The sign is in compliance with the regulations.

4.a Hydrologic Balance: Diversions

The diversions were inspected during the partial inspection. All diversions were in good working condition. Almost all of the culvert inlet had tumble weeds in front of them, as they collect in the low spots. The tumble weeds were removed from the inlets during the inspection and disposed of in the noncoal waste dump bins.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

As a follow up to the OSM complete oversight inspection the pond inlets were revisited and needed maintenance was discussed along with access point to do the maintenance. The work will be scheduled to accomplish the maintenance work.

22. Other

A piece of sheet metal has blown from the storage yard into on the inlets to sediment pond #2. The sheet metal needs to be removed from the inlet.
