2. Signs and Markers

Mine identification sign is posted at the entrance into the mining permit area. The sign displays the name, address, Phone number and mining permit number as required by law.

4.a Hydrologic Balance: Diversions

Road diversions were all open and functional. The diversion entering sediment pond #2 the larger sediment pond was impacted by several high intensity storms. The undisturbed bypass culvert entrance is plugged and damage to the diversion is evident. The storms obviously exceeded the design storm events for the diversion and pond. Shane Campbell was on site and work has been scheduled through his construction company SCAMP to address the damage and needed repairs. DEQ Mike Herkimer was at the site last week to conduct a DEQ reconnaissance inspection of the UPDES sites. The Damage from the storm events occurred prior to his visit.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment pond #2 the larger sediment pond discharged during the several large storm events that exceeded the designed storm events. This was evident from the high water marks of the sides and embankment of the pond. In addition there is wood and debris on top of the lower discharge stand pipe where the water existed the pond. The material on top of the stand pipe will need to be removed at the same time as the repair work on the pond diversion and undisturbed bypass culvert.

5. Explosives

The explosive storage area has signs identifying the area and the magazines are grounded properly.

7. Coal Mine Waste, Refuse Piles, Impoundments

No refuse pile is currently associated with this mine site.

8. Noncoal Waste

The mine site was free of noncoal waste items outside of an approved containment structure or facility.
