2. Signs and Markers

The identification sign posted at the entrance into the mining permit area contained the name, address, phone number and permit number of the operator. This meets the requirements designated for identification signs.

4.a Hydrologic Balance: Diversions

Minimal work was identified during the partial inspection regarding diversions. The upper most inlet needs to be cleaned and the diversion graded leading into it. A trash rack was discussed for the inlet leading directly into sediment pond #2.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

A small amount of water is contained in sediment pond #2. The pipe in the base of pond #2 has been removed. Sediment pond #1 has been cleaned to aid in the installation of the undisturbed pipe by-pass under the pond. Material is stacked in the pond. Culvert is being stored adjacent to the topsoil pile.

5. Explosives

Powder and cap magazine are identified by signs and are grounded against lighting strikes as required.






