2. Signs and Markers

The mine identification sign is posted at the entrance into the mine site at the permit boundary entrance. The sign lists the name, address, phone number and permit number of the operator. The sign meets the standards set forth in the regulations and is compliant with the law.

4.a Hydrologic Balance: Diversions

The upper most diversion near the portal is plugged and needs to be cleaned. Contacted Karin Madsen with this and another required maintenance for the site.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The larger sediment pond has culvert rings from the construction of the new undisturbed bypass culvert laying at the base of the spillway. These items need to be removed. A ramp of dirt was constructed to build a ramp into the base of the pond during the construction for the new bypass undisturbed culvert. The ramp needs to be removed to return the pond to the designed capacity.

The small sediment pond has a culvert ring laying by the discharge outlet of the pond. This ring needs to be removed. In addition the sediment pond needs to be cleaned. There are sediment accumulations built up around the discharge pipe and the drainage inlets into the pond. This build up has created a sediment delta near the discharge stand pipe.

8. Noncoal Waste

There was intermittent trash throughout the site that needs to be gathered and disposed of.
