2. Signs and Markers

The identification sign located at the entrance into the mining site and permit area was inspected for detail. The information displayed on the sign includes the name, Address, phone number and mining permit number as required by law. The sign is large enough to be clearly read. The sign is in compliance with the requirements of the law.

4.a Hydrologic Balance: Diversions

Diversions were open and functional. Some tumble weeds were in the reaches of the upper diversions. The upper most culvert inlet has had one of the rocks used to amour the inlet slide over a portion of the inlet. The rock needs to be re-aligned to ensure that it does not block the flow path.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The smaller sediment was partially cleaned. The remainder of the pond is still set to be cleaned in the future.

5. Explosives

Powder and cap magazines are grounded adequately and have the proper identification signs.
