## **2. Signs and Markers**

The identification signs for the Lila Canyon Mine is posted at the entrance leading into the mine site. The name, address, phone number and mining permit are clearly displayed on the sign. This information meets the requirements the regulations for identification signs.

### **4.a Hydrologic Balance: Diversions**

One culvert inlet located along side of the main access road leading up toward the portal pad is in need of maintenance. Sediment accumulations have reached the point that the sediment needs to be removed from in front of the inlet to provide for adequate capacity.

### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

Sediment ponds were dry.

## **5. Explosives**

Explosive storage area contains powder and cap magazines. The area is identified by proper signage and the magazines are grounded.
