2. Signs and Markers

The mine identification sign is posted at the entrance into the mining permit area. The sign displays the name, address, phone number and mining permit number of the operator of the Lila Canyon Mine, The sign is in compliance with the coal rules.

4.a Hydrologic Balance: Diversions

The second culvert inlet from the top of the mine site down is now open and functional. The coal storage pile had previous filled this inlet in. The upper most culvert inlet on the last inspection had a small rock in from of the inlet. The rock was removed, however now a large boulder is in front of the inlet and needs to be removed.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The small sediment pond still has sediments built up around the decant pipes and needs to be cleaned.

The powder and cap magazine were checked. The signs for the magazines meet the requirements as far as contents and placement.

16.a Roads: Construction, Maintenance, Surfacing

Some longwall equipment is still storage along the road way to the topsoil pile and storage yard. The longwall move is slated to be completed in February. The equipment should then all be moved underground.
