## **2. Signs and Markers**

There is only one identification sign at the Lila Canyon Mine. This sign is placed at the contact point of the end of the county road and the start of the mining permit area. The sign displays as required the name, address, phone number and Utah mining permit number of the operator. The sign is in compliance with the requirements of the law.

### **4.a Hydrologic Balance: Diversions**

All of the diversions listed in the previous inspection report as needed maintenance have been addressed. One culvert inlet at the top of the access road needs additional cleaning. The inlet is still functional, but requires maintenance.

## **5. Explosives**

The explosive storage area is secure. Sign placement and grounding against lightning strikes are according to the requirements of the regulations.

## **7. Coal Mine Waste, Refuse Piles, Impoundments**

There is no refuse pile associated with this mine site.
