## **2. Signs and Markers**

There is one sign used at the Lila Canyon mine as a identification sign at the entrance into the mining permit area. This sign posts the name, address, phone number and mining permit number for the operator of the Lila Canyon mine, UtahAmerican Energy. The sign meets the requirements of the regulations as is therefore compliant.

### **4.a Hydrologic Balance: Diversions**

Fusible pipe identified on the prior inspection within the reaches of the main access road diversion is still present. The lengths of pipe in the diversion need to be removed. Flow will still meander around the obstruction due to the gradient slope present, but the designed flow path is interrupted.

## **8. Noncoal Waste**

Minimal noncoal waste items were observed at various locations outside on an approved storage facility. Care should be taken to contain these items in the approved storage areas.
