2. Signs and Markers

At the Lila Canyon mine there is one identification sign posted at the entrance into the mine site. This identification sign displays the name of the operator followed by the address, phone number and mining permit number issued by the Division of Oil, Gas and Mining. The sign was evaluated and found to be in compliance with the requirements found in the coal rules for identification signs.

3. Topsoil

New topsoil added to the topsoil pile still needs to be seeded.

4.a Hydrologic Balance: Diversions

Diversions are open and functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The large sediment pond is dry. The small sediment pond had a small amount of water. The sediment load appears to be increasing. The ponds are to be surveyed in the near future to determine the sediment elevation.

5. Explosives

The explosive storage area is signed and the magazines are grounded.
