2. Signs and Markers

There is only one identification sign on site for the Lila Canyon mine. The sign placement is at the entrance into the permit area at the base of the small sediment pond. The sign displays the name, address, phone number and mining permit number of the operator of the Lila Canyon mine. The sign is in compliance.

4.a Hydrologic Balance: Diversions

Numerous diversions need attention from the winter storm events that have taken place in the last several weeks.

- The diversion below the new storage area needs to be cleaned and deepened.
- Pipe in same diversion listed above.
- Road diversions leading to portal area have mud smashed or pushed into their reaches from travel on the roads after storm events. Portions need to be cleaned and/or re-graded.

8. Noncoal Waste

A few noncoal waste items were observed.

- Plastic wrap in swell to new warehouse pad.
- Smashed oil can along side of portal access road, at last switchback.

18. Support Facilities, Utility Installations

After the site visit the surface facilities map was reviewed and it appears that there are several more conex trailers around the warehouse area on the main pad that are not shown on the surface facilities map. A survey by the company needs to be done of the facility to make sure that all recent additions through permit amendments to the site have been added to their surface facilities map and then submit a revised map to the Division. This item will be followed up on the next inspection.

Another Domed tent structure is being planned to be placed on the storage pad above the small sediment pond and below the safety office. The size is estimated to be 40 feet by 60 feet. This domed tent will then be used as a shop area. A permit amendment is being prepared for submittal. The area is in the existing disturbed area. All runoff will report to a pond. The bond will need to be adjusted.
