2. Signs and Markers

The mine identification sign is placed at the entrance into the permit area by the small sediment pond. The sign displays the name, address, phone number and mining permit number as required by law. The sign is in compliance.

4.a Hydrologic Balance: Diversions

The road diversion between the truck load out pad and the coal storage pad has material in its reaches from wet muddy conditions where the road has mushroomed into the diversion from vehicle travel. The diversion needs to be cleaned and re-defined.

7. Coal Mine Waste, Refuse Piles, Impoundments

There are no refuse piles associated with this mine site.

18. Support Facilities, Utility Installations

The new tent installation on the lower pad below the safety office has been conditionally approved and is being constructed. The bond still needs to be posted.

Several conex trailers were observed on the main pad by the warehouse, but are not on the surface facilities map. These trailers are used for storage. The trailers need to be placed on the map and bonded for if they are not in the current MRP.
