2. Signs and Markers

There is an identification sign posted at the entrance into the mining permit area. This sign posts the name, address, phone number and mining permit number of the Lila Canyon mine.

4.a Hydrologic Balance: Diversions

Several diversions were noted during the partial inspection as needing maintenance.

The road diversion from the explosive storage pad area to the last road switch back needs to be re-established.

The inlet in the road diversion near the bath house is half full of sediment and needs to be cleaned.

Both areas of concern are still functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment level in the smaller sediment pond has reached a level by the discharge pipes that now requires the pond to be cleaned to allow adequate storage capacity.

7. Coal Mine Waste, Refuse Piles, Impoundments

There is no refuse pile associated with this mine site.

8. Noncoal Waste

Trash items were observed along the road and the diversions near the trash storage area. Some tumble weeds are also in the diversion.
