CORRECTED NOTICE OF PERMIT APPROVAL

To Whom It May Concern:

Pursuant to the Utah Coal Mining and Reclamation Act (Utah Code Annotated 1953, Section 40-10-1 et seq), and the "Regulations Pertaining to Surface Effects of Underground Coal Mining Activities" (Final Rules of the Utah Board of Oil, Gas and Mining), the Utah Division of Oil, Gas and Mining has issued a permit to mine coal to Beaver Creek Coal Company for its permit application No. ACT/007/C16. The Company will operate in the permit area in accordance with the approved Mining and Reclamation Plan for the Gordon Creek #2 and #7 Mines associated with Federal Leases U-53159 and U-8319 included in the following description of the permit area:
