4. HYDROLOGIC BALANCE

a) Diversions--Culvert CD-1 is in good repair and free from obstruction. Maintenance of this culvert was requested in last month's inspection report.

b) Sediment Ponds and Impoundments--Sediment ponds are in series. Both ponds contained some water because of recent rains, but neither had discharged.

The operator informed the inspector that sheep had recently been on the site. The sheep were absent during the inspection, but damage to the vegetation and to the graded surface from their presence was evident.
