Mining ceased at this site in December 1990. All demolition of surface facilities have been completed and portals have been sealed. The review of the reclamation plan by the Division is currently underway in light of the recent DOGM Directive Tech-002, Approximate Original Contour Requirements. Reclamation may commence this year if a plan can be approved.
