1. Permits, Change, Transfer, Renewal, Sale

Three permitting items were discussed, the five year permit renewal that is due April 28, 2004, an application for phase two bond release, and the annual report due March 1, 2004. These applications will most likely be submitted separately.

2. Signs and Markers

Signs were adequately posted at the entrance to the reclaimed site. Recent snows had drifted in the access road up to 3' in places making access impossible.

4.d Hydrologic Balance: Water Monitoring

Water monitoring data is up to date in the database for the fourth quarter of 2003.
