2. Signs and Markers

The sign with the required information was posted at the entrance to the reclaimed area. The property is privately owned and, as such some of the signs noting that, were painted orange to indicate no trespassing.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The three-celled sediment pond was covered with approximately 10" of snow.

9. Protection of Fish, Wildlife and Related Environmental Issues

With the current snow depth at 10" the deer and elk that are common to the area have moved to lower elevations for the winter months.

21. Bonding and Insurance

The company is preparing an application for phase two bond release. Since the site was reclaimed approximately eight years ago, the review for phase two bond release should be fairly straight forward.
